

## CHAP. Iviii.

An Act for confirming certain Provisional Orders made by the
A.D. 1871.

Board of Trade under The General Pier and Harbour Act, 1861, relating to Curran, Hastings, Herne Bay, Hornsea, Northam, and Stornoway. [29th June 1871.]

WHEREAS a Provisional Order made by the Board of Trade $24 \& 25$ Vict. under The General Pier and Harbour Act, 1861, is not of c. 45.
any validity or force whatever until the confirmation thereof by Act of Parliament :

And whereas it is expedient that the several Provisional Orders made by tho Board of Trade under the said Act, and set out in the schedule to this Act, be confirmed by Act of Parliament:

Be it therefore enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:

1. The several Orders set out in the schedule to this Act shall be Confirmaand the same are hereby confirmed, and all the provisions thcreof tion of in manner and form as they are set out in tho said schedule orders in schule. shall, from and after the passing of this Act, have full validity and force.
2. Nothing contained in this Act or in the Herne Bay Order Saving hereby confirmed shall take away, abridge, or prejudicially affect $\begin{gathered}\text { rights of } \\ \text { Herne Bay }\end{gathered}$ any right, power, authority, or privilege vested in, exercised, or Oyster enjoyed by the Herne Bay, Hampton, and Reculver Oyster Fishery $\begin{gathered}\text { Fishery } \\ \text { Conpany. }\end{gathered}$ Company.
3. This Act may be cited as the Pier and Harbour Orders Short title. Confirmation Act, 1871 (No. 1).

## CURRAN.

Order for the maintenance and regulation of the Pier and Harbour of Curran in the parish of Larne in the county of Antrim.

1. James Chaine of Ballycraigy in the county of Antrim, his heirs, successors, and assigns, owners for the time being of the pier and harbour of Curran in the parish of Larne in the county of Antrim, shall be the Undertakers for carrying this Order into execution.
2. Subject and according to the provisions of this Order, the Undertakers may demand and receive, in respect of the vessels, goods, persons, and things described in the schedule to this Order, any sums not exceeding the rates in that schedule specified.
3. The Board of Trade, at any time and from time to time, on an application in writing from six or more of the owners of vessels or boats resorting to the said pier and harbour, and after hearing the Undertakers, may, if the rates or dues appear to the Board of Trade excessive or disproportionate to the expenditure on the works of the pier and harbour or to the benefits conferred, reduce the same or any of them, with power to the Board of Trade to raise them again to amounts not excceding those in the said schedule specified.
4. The Uudertakers shall keep a printed copy of the rates and dues for the time being leviable under this Order exhibited in the office of the collector of
rates and dues, and accessible to all persons at all times while the office is in use for business, and shall also at all times keep printed copies of such rates and

 dues, and also printed copies of this Order, with the schedule thereto, and sell such copies to any person desiring to buy the same at a price not exceeding one penny per copy.5. Fishing vessels bolonging to countries with which for the time being treaties exist exempting from duties and port charges such vessels when forced by stress of weather to seek shelter in the ports or on the coasts of the United

Certain fishing vessels exempt from tolls. Kingdom, shall, when forced by stress of weather to make use of the pier and harbour of Curran, and not breaking bulk while making use thereof, be exempt from rates and dues leviable under this Order.
6. Officers of customs, being in the execution of their duty, shall at all times Custom House have free ingress, passage, and egress on, into, and along the said pier and officers exempt harbour by land, and with their vessels and otherwise, without payment.

7. The rates received under this Order shall be applicable for the purposes Appleation of and in the order following, and not otherwise; (that is to say,)
(1.) In paying the expenses of and comected with the applying for, obtaining, and making of this Order:
(2.) In paying the expenses of the maintenance, repair, management, and regulation of the pier and harbour:
(3.) So much of the rates as may remain after answering the two several purposes aforesaid shall be applicable by the Undertakers to and for their own proper use and benefit.
8. The following provisions of the Harbours, Docks, and Piers Clauses Act, Parts of Har1847, shall not be incorporated with this Order, namely, sections 16, 17, 18, 19, 25, and 26, and the Undertakers shall not be bound to comply with the requirements of sections 14 and 15 of the said Act, unless and until required so to do by the Board of Trade.
9. The Undertakers shall have the appointment of meters and weighers on or Meters and in connexion with the said pier and harbour. weighers.
10. The Undertakers shall be a local authority within the meaning of the Undertakers to Merchants Shipping Act, 1854, and the Acts amending the same, with all the be a local powers thereby conferred on local authorities,
11. The Undertakers shall, at the outer extremity of the pier and harbour, Iight to be exexhibit from sumset to sumrise such light (if any) as shall from time to time be libited. directed by the Commissioners of Irish Lights.
12. This Order may be cited as "The Chirran Picr and Harbour Order, Short title, 1\% 71.
