THE CITY OF CAMBRIDGE
AREA C (CONSOLIDATION) ORDER 1993
(AMENDMENT NO.7) ORDER 1996

Cambridge City Council ("the Council") in pursuance of arrangements made under Section 101 of the Local Government Act 1972 with Cambridgeshire County Council in exercise of the powers of the said County Council under Sections 1, 2, 3, 4, 19, 32, 35, 45, 46, 49, 63, and 64 of the Road Traffic Regulation Act 1984 ("the Act of 1984") (as amended) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby make the following Order:

1. This Order shall come into operation for all purposes on the 21st day of April 1997 and may be cited as The City of Cambridge Area C (Consolidation) Order 1993 (Amendment No.7) Order 1996
2. In this Order the expression "the Order of 1993" shall mean The City of Cambridge Area C (Consolidation) Order 1993 and any reference to the Order of 1993 shall be construed as a reference to that Order as varied or amended.
3. The Order of 1993 shall be amended and have effect as though in Schedule 2 Part 1 all references to Chapel Street Church Street Logan's Way and Mariner's Way were deleted and substituted by the following:

CHAPEL STREET	On its west side from a point 14 metres south of the centreline of High Street Chesterton for a distance of 24 metres in a southeasterly direction
LOGAN'S WAY	On both sides from the centreline of St. Andrew's Road for a distance of 73 metres in a southeasterly direction
MARINER'S WAY	On its northwest side from the centreline of Logan's way for a distance of 85 metres in a southwesterly direction
MARINER'S WAY	On its southeast side from the centreline of Logan's Way for a distance of 69 metres in a southwesterly direction
ST. ANDREW'S ROAD	On both sides from a point 12 metres west of the centreline of Logan's Way to a point 125 metres south of the centreline of the northeast-arm of Church Street southwest

4. The Order of 1993 shall be amended and have effect as though in Schedule 2 Part 2 all references to Chapel Street Church Street and St. Andrew's Road were deleted and substituted by the following:

CHURCH STREET (northeast-arm) On both sides from a point 15 metres northeast of the centreline of the southwest northwest-southeast arm of Church Street northeastwards to a point 70 metres southwest of the centreline of

CHAPEL STREET On its west side from the centreline of the northeast-southwest arm of Church Street for a distance of 8 metres in a northerly direction

CHAPEL STREET On its east side from the centreline of the northeast-southwest arm of Church Street for a distance of 12.6 metres in a northerly direction

ST. ANDREW'S ROAD On both sides from a point 12 metres southeast of the centreline of the northeast-southwest arm of Church Street for a distance of 33 metres in a southeasterly direction
