THE CITY OF CAMBRIDGE AREA D (CONSOLIDATION) ORDER 1993 (AMENDMENT NO.6) ORDER 1995

Cambridge City Council ("the Council") in pursuance of arrangements made under Section 101 of the Local Government Act 1972 with Cambridgeshire County Council in exercise of the powers of the said County Council under Sections 1, 2, 3, 4, and 64 of the Road Traffic Regulation Act 1984 ("the Act of 1984") (as amended) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby make the following Order:

- 1. This Order shall come into operation for all purposes on the 20th day of November 1995 and may be cited as The City of Cambridge Area D (Consolidation) Order 1993 (Amendment No.6) Order 1995
- 2. In this Order the expression "the Order of 1993" shall mean The City of Cambridge Area D (Consolidation) Order 1993 and any reference to the Order of 1993 shall be construed as a reference to that Order as varied or amended.
- 3. The Order of 1993 shall be amended and have effect as though the following additions were made to Schedule 2 Part 2:

GARLIC ROW On its northeast side from a point 29 metres southeast of the centreline of Mercers Row northwestwards to its junction with Oyster Row

MERCERS ROW On its northwest side from its junction with Garlic Row northeastwards to its junction with Swann's Road

MERCERS ROW On its southeast side from the centreline of Garlic Row for a distance of 29 metres in a northeasterly direction

OYSTER ROW On both sides from the centreline of Stanley Road for a distance of 17 metres in a northeasterly direction

OYSTER ROW On its northwest side from a point 107 metres northeast of the centreline of Stanley Road northeastwards to its junction with Garlic Row

OYSTER ROW On both sides from the centreline of Garlic service road Row for a distance of 17 metres in a northerly direction

RIVERSIDE On its southeast side from a point 9 metres northeast of the centreline of Stanley Road for a distance of 19 metres in a southwesterly direction

STANLEY ROAD

On both sides from the centreline of
Riverside for a distance of 16 metres
in a southeasterly direction
