AREA E (CONSOLIDATION) ORDER 1993
(AMENDMENT NO.5) ORDER 1994

Cambridge City Council ("the Council") in pursuance of arrangements made under Section 101 of the Local Government Act 1972 with Cambridgeshire County Council in exercise of the powers of the said County Council under Sections 1, 2, 3, 4, 19, 32, 35, 45, 46, 49, 63, and 64 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby make the following Order:

1. This Order shall come into operation for all purposes on the 14th day of November 1994 and may be cited as The City of Cambridge Area E (Consolidation) Order 1993 (Amendment No.5) Order 1994

2. In this Order the expression "the Order of 1993" shall mean The City of Cambridge Area E (Consolidation) Order 1993 and any reference to the Order of 1993 shall be construed as a reference to that Order as varied or amended.

3. The Order of 1993 shall be amended and have effect as though the following deletions were made from Schedule 2 Part 2:

MILL ROAD On its north side from its junction with Great Eastern Street to a point 15 metres east of its junction with Cavendish Road

MILL ROAD On its north side from a point 15 metres west of its junction with Sedgwick Street to its junction with Hemingford Road

4. The Order of 1993 shall be amended and have effect as though the following deletion was made from Schedule 2 Part 16:

MILL ROAD On its north side from a point 15 metres east of its junction with Cavendish Road to a point 15 metres west of its junction with Sedgwick Street

5. The Order of 1993 shall be amended and have effect as though the following deletions were made from Schedule 3 Part 1:

MILL ROAD On its north side from a point 15 metres west of its junction with Cavendish Road for a distance of 30 metres in an easterly direction

MILL ROAD On its north side from its junction with Sedgwick Street for a distance of 15 metres in a westerly direction

6. The Order of 1993 shall be amended and have effect as though the following deletion was made from Schedule 3 Part 7:

MILL ROAD On its north side from a point 15 metres east of its junction with Cavendish Road to a point 15 metres west of its junction with Sedgwick Street

7. The Order of 1993 shall be amended and have effect as though the following additions were made to Schedule 2 Part 2:

MILL ROAD On its north side from its junction with Great Eastern Street to a point 19.5 metres east of the centreline of Cavendish Road

MILL ROAD On its north side from a point 31 metres west of the centreline of Sedgwick Street to its junction with Hemingford Road

8. The Order of 1993 shall be amended and have effect as though the following addition was made to Schedule 2 Part 11:

MILL ROAD On its north side from a point 19.5 metres east of the centreline of Cavendish Road to a point 31 metres west of the centreline of Sedgwick Street

9. The Order of 1993 shall be amended and have effect as though the following additions were made to Schedule 3 Part 1:

MILL ROAD On its north side from a point 15 metres west of the centreline of Cavendish Road for a distance of 34.5 metres in an easterly direction

MILL ROAD On its north side from the centreline of Sedgwick Street for a distance of 31 metres in a westerly direction
