THE CITY OF CAMBRIDGE
AREA E (CONSOLIDATION) ORDER 1993 (AMENDMENT NO.10) ORDER 1996

Cambridge City Council ("the Council") in pursuance of arrangements made under Section 101 of the Local Government Act 1972 with Cambridgeshire County Council in exercise of the powers of the said County Council under Sections 1, 2, 3, 4, 19, 32, 35, 45, 46, 49, 63, and 64 of the Road Traffic Regulation Act 1984 ("the Act of 1984") (as amended) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby make the following Order:

1. This Order shall come into operation for all purposes on the 1st day of July 1996 and may be cited as The City of Cambridge Area E (Consolidation) Order 1993 (Amendment No.10) Order 1996

2. In this Order the expression "the Order of 1993" shall mean The City of Cambridge Area E (Consolidation) Order 1993 and any reference to the Order of 1993 shall be construed as a reference to that Order as varied or amended.

3. The Order of 1993 shall be amended and have effect as though all references to Great Eastern Street in Schedule 2 Part 1 were deleted.

4. The Order of 1993 shall be amended and have effect as though in Schedule 2 Part 2 all references to Great Eastern Street were deleted and substituted by the following:

GREAT EASTERN STREET	On both sides from its junction with Mill Road for a distance of 15 metres in a northerly direction

GREAT EASTERN STREET	On its west side from a point 63 metres north of its junction with Mill Road for a distance of 22 metres in a northerly direction
----------------------	--

GREAT EASTERN STREET	On its west side from a point 196 metres north of its junction with Mill Road northwards to its most northerly point
----------------------	--

GREAT EASTERN STREET	On all sides of the turning head at its northern end
----------------------	---

4. The Order of 1993 shall be amended by the addition of Schedule 2 Part 19 as specified in the FIRST SCHEDULE to this Order.

direction
