AREA E (CONSOLIDATION) ORDER 1993
(AMENDMENT NO.15) ORDER 1997

Cambridge City Council ("the Council") in pursuance of arrangements made under Section 101 of the Local Government Act 1972 with Cambridgeshire County Council in exercise of the powers of the said County Council under Sections 1, 2, 3, 4, 19, 32, 35, 45, 46, 49, 63, and 64 of the Road Traffic Regulation Act 1984 ("the Act of 1984") (as amended) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby make the following Order:

1. This Order shall come into operation for all purposes on the 3rd day of November 1997 and may be cited as The City of Cambridge Area E (Consolidation) Order 1993 (Amendment No.15) Order 1997
2. In this Order the expression "the Order of 1993" shall mean The City of Cambridge Area E (Consolidation) Order 1993 and any reference to the Order of 1993 shall be construed as a reference to that Order as varied or amended.
3. The Order of 1993 shall be amended and have effect as though in Schedule 2 Part 2 all references to Seymour Street were deleted and substituted by the following:

SEYMOUR STREET	On its east and north sides from the centreline of Brookfields for a distance of 127 metres in a northerly and westerly direction
SEYMOUR STREET	On its east side from a point 40 metres north of the centreline of Brookfields Health Centre vehicular access for a distance of 25 metres in a northerly direction
SEYMOUR STREET	On its west side from the centreline of Brookfields for a distance of 19 metres in a northerly direction
SEYMOUR STREET	On its west and south sides from a point 40 metres north of the centreline of Brookfields for a distance of 36 metres in a northerly and westerly direction
SEYMOUR STREET	On its south and west sides from a point 91 metres north of the centreline of Brookfields for a distance of 37 metres in a westerly and northerly direction
SEYMOUR STREET	On its west side from a point 11 metres south of the centreline of Brookfields Health Centre vehicular access for a distance of 21 metres in a northerly direction
SEYMOUR STREET	On its west side from a point 74 metres north of the centreline of Brookfields Health Centre vehicular access for a distance of 23 metres in a northerly direction

SEYMOUR STREET On its south side from the centreline of
Vinery Road for a distance of 78 metres in an
easterly direction

SEYMOUR STREET On its south side from a point 155 metres
 east of the centreline of Vinery Road
for a distance of 27 metres in an
easterly direction

SEYMOUR STREET On its south and west sides from a point 206
metres east of the centreline of Vinery Road
for a distance of 34 metres in an easterly
and southerly direction

SEYMOUR STREET On its north side from the centreline of
Vinery Road for a distance of 15 metres in an
easterly direction

SEYMOUR STREET On its north side from a point 152 metres
 east of the centreline of Vinery Road
for a distance of 38 metres in an
easterly direction

SEYMOUR STREET On its north and east sides from a point 204
metres east of the centreline of Vinery Road
for a distance of 47 metres in an easterly
and southerly direction
