THE CITY OF CAMBRIDGE AREA F (CONSOLIDATION) ORDER 1993 (AMENDMENT NO.2) ORDER 1994

Cambridge City Council ("the Council") in pursuance of arrangements made under Section 101 of the Local Government Act 1972 with Cambridgeshire County Council in exercise of the powers of the said County Council under Sections 1, 2, 3, 4, 19, 32, 35, 45, 46, 49, 63, and 64 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby make the following Order:

- 1. This Order shall come into operation for all purposes on the 9th day of August 1994 and may be cited as The City of Cambridge Area F (Consolidation) Order 1993 (Amendment No.2) Order 1994
- 2. In this Order the expression "the Order of 1993" shall mean The City of Cambridge Area F (Consolidation) Order 1993 and any reference to the Order of 1993 shall be construed as a reference to that Order as varied or amended.
- 3. The Order of 1993 shall be amended and have effect as though all reference to Nightingale Avenue in Part 2 of Schedule 2 was deleted and substituted by the following:

NIGHTINGALE AVENUE On its northwest side from the centreline of its junction with Hills Road for a distance of 86 metres in a northeasterly

direction

NIGHTINGALE AVENUE On its southeast side from the centreline of its junction with Hills Road for a distance of 33 metres in a northeasterly

direction

NIGHTINGALE AVENUE On both sides from the centreline of Queen Edith's Way for a distance of 16 metres in a southerly direction

QUEEN EDITH'S WAY On its south side from a point 12 metres west of the centreline of Nightingale Avenue for a distance of 24 metres in an easterly direction

4. The Order of 1993 shall be amended and have effect as though the following additions were made to Schedule 2 Part 29

KINNAIRD WAY

On both sides from the centreline of

Nightingale Avenue for a distance of 19

metres in a westerly direction

NIGHTINGALE AVENUE On its west side from a point 70 metres south of the centreline of Queen Edith's Way for a distance of 65 metres in a southerly direction

NIGHTINGALE AVENUE On its east side from a point 52 metres south of the centreline of Queen Edith's Way

11 and 27 (odd) Nightingale Avenue

ROTHERWICK WAY On its east side from the centreline of (north-south arm) Nightingale Avenue for a distance of 20 (serving properties metres in a southerly direction nos.1,2 and 12 to 34 inclusive)

ROTHERWICK WAY On its east side from a point 48 metres (north-south arm) south of the centreline of the north-south (serving properties arm of Rotherwick Way for a distance of 62 nos.1,2 and 12 to metres in a westerly direction 34 inclusive)

ROTHERWICK WAY On its west side from the centreline of (north-south arm) Nightingale Avenue for a distance of 114 (serving properties metres in a southerly direction nos.1,2 and 12 to 34 inclusive)

ROTHERWICK WAY On its north side from the centreline of the (west-east arm) north-south arm of Rotherwick Way for a (serving properties distance of 20 metres in a westerly direction nos. 3 to 11 inclusive)

ROTHERWICK WAY On its south side from the centreline of the (west-east arm) north-south arm of Rotherwick Way for a (serving properties distance of 23 metres in a westerly direction nos. 3 to 11 inclusive)

- 5. The Order of 1993 shall be amended and have effect by the addition of Schedule 2 Part 30 as specified by the FIRST SCHEDULE to this Order.
- 6, The Order of 1993 shall be amended and have effect as though the following addition was made to Schedule 23 Part 2  $\,$
