Cambridge City Council ("the Council") in pursuance of arrangements made under Section 101 of the Local Government Act 1972 with Cambridgeshire County Council in exercise of the powers of the said County Council under Sections 1, 2, 3, 4, 19, 32, 35, 45, 46, 49, 63, and 64 of the Road Traffic Regulation Act 1984 ("the Act of 1984") (as amended) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby make the following Order:

- 1. This Order shall come into operation for all purposes on the 11th day of May 1998 and may be cited as The City of Cambridge Area F (Consolidation) Order 1993 (Amendment No.14) Order 1998
- 2. In this Order the expression "the Order of 1993" shall mean The City of Cambridge Area F (Consolidation) Order 1993 and any reference to the Order of 1993 shall be construed as a reference to that Order as varied or amended.
- 3. The Order of 1993 shall be amended and have effect as though the following additions were made to Schedule 2 Part 2:

GLEBE ROAD On both sides from the centreline of
Hills Road for a distance of 21 metres
in an easterly direction

HILLS ROAD

On its east side from a point 7 metres

north of the centreline of Glebe Road

for a distance of 15 metres in a

southerly direction

On its east side from a point 7.5 metres north of the centreline of Holbrook Road for a distance of 18 metres in a southerly direction

HILLS ROAD On both sides from the centreline of (service road adjacent Worts' Causeway for a distance of 14 to nos.335 to 355) metres in a northerly direction

HOLBROOK ROAD

On both sides from the centreline of
Hills Road for a distance of 31
metres

in an easterly direction

NIGHTINGALE AVENUE On its west side from a point 32 metres north of the centreline of Topcliffe
Way for a distance of 44 metres in a southerly direction
