**THE CITY OF CAMBRIDGE  
AREA F (CONSOLIDATION) ORDER 1993 (AMENDMENT NO. 30) ORDER 2003**

Cambridge City Council ("the Council") in pursuance of arrangements made under Section 101 of the Local Government Act 1972 with Cambridgeshire County Council in exercise of the powers of the said County Council under Sections 1, 2, 3, 4, 19, 32, 35, 45, 46, 49, 63, and 64 of the Road Traffic Regulation Act 1984 ("the Act of 1984") (as amended) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby make the following Order:

1. This Order shall come into operation for all purposes on the 19th day of May 2003 and may be cited as The City of Cambridge Area F (Consolidation) Order 1993 (Amendment No.31) Order 2003.
2. In this Order the expression "the Order of 1993" shall mean The City of Cambridge Area F (Consolidation) Order 1993 and any reference to the Order of 1993 shall be construed as a reference to that Order as varied or amended.
3. The Order of 1993 shall be amended and have effect as though the following additions were made to Schedule 2 Part 29:

FIELD WAY	On its west side from point 106 metres north of the centreline of Worts' Causeway for a distance of 7 metres in a northerly direction
FIELD WAY	On its east side from point 106 metres north of the centreline of Worts' Causeway northwards to its junction with Bowers Croft
FIELD WAY	On its northeast side from point 146 metres north of the centreline of Worts' Causeway southwards to its junction with Bowers Croft.
FIELD WAY (west-east arm properties nos. 5 to 14)	On its south and east sides from a point 55 metres east of the centreline of Bowers Croft southwards and westwards to its most westerly point serving
FIELD WAY (west-east arm serving properties nos. 5 to 14)	On all sides of the turning head at its western end
FIELD WAY (north-south arm serving properties nos. 15 to 22)	On its west side from a point 19 metres south of the centreline of the west-east arm of Field Way (serving properties numbers 1-4) northwards to its most northerly point
FIELD WAY (north-south arm properties nos. 15 to 22)	On its north and east sides from a point 55 metres west of the centreline of its junction with Bowers Croft westwards and northwards to its most serving northerly point
FIELD WAY (north-south arm serving properties nos. 15 to 22)	On all sides of the turning head at its northernmost end
BOWERS CROFT (north-south arm serving properties nos. 1 to 11)	On its west side from a point 41 metres north west of the centreline of Field Way southwards to its junction with Field Way
