THE CITY OF CAMBRIDGE AREA F (CONSOLIDATION) ORDER 1993 (AMENDMENT NO.32) ORDER 2003

Cambridge City Council ("the Council") in pursuance of arrangements made under Section 101 of the Local Government Act 1972 with Cambridgeshire County Council in exercise of the powers of the said County Council under Sections 1, 2, 3, 4, 19, 32, 35, 45, 46, 49, 63, and 64 of the Road Traffic Regulation Act 1984 ("the Act of 1984") (as amended) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby make the following Order:

- 1. This Order shall come into operation for all purposes on the 8th day of December 2003 and may be cited as The City of Cambridge Area F (Consolidation) Order 1993 (Amendment No.32) Order 2003.
- 2. In this Order the expression "the Order of 1993" shall mean The City of Cambridge Area F (Consolidation) Order 1993 and any reference to the Order of 1993 shall be construed as a reference to that Order as varied or amended.
- 3. The Order of 1993 shall be amended and have effect as though in Schedule 2 Part 29 the following references were deleted:

KINNAIRD WAY

On both sides from the centreline of its junction with Nightingale Avenue for a distance of 19 metres in a westerly direction

WORTS' CAUSEWAY On its north side from a point 48 metres east of the centreline of its junction with Field Way for a distance of 227 metres in an easterly direction

WORTS' CAUSEWAY On its south side from a point 116 metres east of the centreline of its junction with Alwyne Road for a distance of 110 metres in an easterly direction

WORTS' CAUSEWAY On its south side from a point 16 metres east of the centreline of Hills Road (service road to nos. 335 to 355) eastwards to a point 150 metres east of the centreline of Alwyne Road

4. The Order of 1993 shall be amended and have effect as though the following additions were made to Schedule 2 Part 29:

TOPCLIFFE WAY (service road, serving properties nos. 1 to 7 odd)

At its eastern end on both sides from the centreline of its junction with Topcliffe Way for a distance of 17 metres in a westerly direction

WORTS' CAUSEWAY On its north side from a point 48 metres east of the centreline of Field Way for a distance of 110 metres

WORTS' CAUSEWAY On its south side from a point 16 metres east of the centreline with Hills Road (service road to nos. 335 to 355 Hills Road) eastwards to a point 158 metres east of the centreline of Field Way

5. The Order of 1993 shall be amended and have effect as though the following additions were made to Schedule 2 Part 2:

ALMONERS AVENUE On both sides from the centreline of its junction with Queen Edith's Way for a distance of 18 metres in an easterly direction

KINNAIRD WAY	On both sides from the centreline of its junction with Nightingale Avenue for a distance of 32 metres in a westerly direction
WORTS' CAUSEWAY	On both sides from point 158 metres east of the centreline of Field Way eastwards to its junction with Limekiln Road
