THE CITY OF CAMBRIDGE AREA F (CONSOLIDATION) ORDER 1993 (AMENDMENT NO. 35) ORDER 2004

Cambridge City Council ("the Council") in pursuance of arrangements made under Section 101 of the Local Government Act 1972 with Cambridgeshire County Council in exercise of the powers of the said County Council under Sections 1, 2, 3, 4, 19, 32, 35, 45, 46, 49, 63, and 64 of the Road Traffic Regulation Act 1984 ("the Act of 1984") (as amended) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby make the following Order:

- 1. This Order shall come into operation for all purposes on the 17th day of September 2004 and may be cited as The City of Cambridge Area F (Consolidation) Order 1993 (Amendment No. 35) Order 2004.
- 2. In this Order the expression "the Order of 1993" shall mean The City of Cambridge Area F (Consolidation) Order 1993 and any reference to the Order of 1993 shall be construed as a reference to that Order as varied or amended.
- 3. The Order of 1993 shall be amended and have effect as though in Schedule 2 Part 2 the following references were deleted:

CHERRY HINTON ROAD	On its south side from a point 46 metres west of its junction with Hinton Avenue to its junction with Mowbray Road
CHERRY HINTON ROAD	On its south side from a point 22 metres west of its junction with St. Margaret's Square for a distance of 36 metres in an easterly direction
CHERRY HINTON ROAD	On its south side from a point 16 metres west of its junction with Blinco Grove for a distance of 66 metres in an easterly direction
CHERRY HINTON ROAD	On its south side from a point 36 metres west of its junction with Rock Road for a distance of 61 metres in an easterly direction
CHERRY HINTON ROAD	On its south side from a point 41 metres west of its junction with Hartington Grove for a distance of 61 metres in an easterly direction
CHERRY HINTON ROAD	On its south side from a point 12 metres west of its junction with Rathmore Road for a distance of 24 metres in an easterly direction
CHERRY HINTON ROAD	On its south side from its junction with Hills Road to a point 67 metres west of its junction with Rathmore Road
CHERRY HINTON ROAD	On its north side from its junction with Hills Road to its

4. The Order of 1993 shall be amended and have effect as though the following addition was made to Schedule 2 Part 2:
